### TENDER – ARENA ROOF AND SIDING REPAIR

hereby submit a tender to supply the following labour

and material:

- 1) Asphalt Roof
  - a) Remove, dispose, and replacement of existing asphalt roofing material from front of Arena
  - b) Inspect and replace any damaged roofing sheeting upon approval from Public Works manager
  - c) Remove all older ice and water shield (if any) from the outside and replace with new insulation and weatherproof barrier
  - d) Installation of an ice and water shield underlay for the entire section of the roof being replaced
  - e) Install new quality 30-year shingles to colour match the existing asphalt material \*\*All new structures are to be tested for water leaks and to ensure the integrity of the structure is sound\*\*
- 2) Gable ends
  - a) Enclose both gable ends of roof where it meets metal roofing and install appropriate flashing to be tied into existing metal roof
- 3) Metal roof structure
  - a) Inspect and replace popped nails and replace with appropriate screws.

- 4) Siding
  - a) Enclose exterior door openings on north and south side of building and install metal siding
  - b) Cover window structures on north and south side of building with metal siding.
  - c) Inspect and replace popped nails and replace with appropriate screws.
  - d) Replacing siding as required upon approval from Public Works manager \*\*
    \*\*Exact quantity of siding to be replaced unknown at this time. Bidders to
